## LIMITED POWER OF ATTORNEY

- Pay all taxes, registration fees, and lien-release fees due in connection with the title transfer, charging same to the Grantor's billing on file or invoicing same separately;
- Communicate with the Department of Motor Vehicles (or equivalent provincial authority in Canada), the originating lender, and any prior registered owner to clear liens or correct chain-of-title irregularities;
- Receive and forward to the Grantor the original certificate of title, registration documents, and license plates upon completion;
- Sign delivery receipts, transport bills of lading, and inspection certificates for the carrier engaged to deliver the Vehicle.

## Acts Expressly Excluded

This is a Limited Power of Attorney. The Attorney-in-Fact is not authorised to:

- Sell, pledge, or otherwise transfer the Vehicle to any party other than the Grantor;
- Encumber the Vehicle with a lien or financing interest;
- Operate the Vehicle for any purpose other than transport to the Grantor;
- Bind the Grantor to any contract, debt, or obligation unrelated to title transfer of this specific Vehicle.

## Term

This Power of Attorney is effective from the date of signature below and remains in force until the earlier of: (a) successful issuance and delivery of the certificate of title to the Grantor; or (b) ninety (90) days from the date of signature. Upon either event, this authority automatically terminates without further action.

## Revocation

The Grantor may revoke this Power of Attorney at any time by written notice delivered to the Attorney-in-Fact at support@repomarket.example. Revocation does not affect any act lawfully performed before the Attorney-in-Fact received written notice of revocation.

The Grantor agrees to indemnify the Attorney-in-Fact against any liability incurred while acting in good faith within the scope of authority granted herein, except for liability arising from gross negligence or wilful misconduct.

This Power of Attorney is governed by the laws of the jurisdiction in which the Vehicle is registered upon transfer.
