- 4.5 Any disputes arising under this Agreement shall be resolved through binding arbitration administered under the rules of the American Arbitration Association in the jurisdiction of the Seller's principal place of business.
- 4.6 This Agreement constitutes the entire understanding between the parties with respect to the subject matter and supersedes all prior negotiations, representations, or agreements, whether written or oral.
- 4.7 The Buyer represents that they are at least 18 years of age, have the legal capacity to enter into this Agreement, and have provided accurate identification and contact information.
